Kia ora

A regular topic of discussion in Northland is the parking of cars over the footpath, in areas where the streets are narrow. So you may be interested to know that the Council is currently seeking feedback on this and some other parking matters.

The Council is proposing to revoke the current traffic bylaw and create a new one, that will enable WCC to implement the parking policy changes that WCC consulted on in 2020. CVRA made a submission on the policy last year (see our website) - the policy allows for the establishment of residents parking zones, and for targeted parking interventions. We expressed our interest in being involved in any discussions of such zones around Northland, as we are particularly interested in controls to limit commuter parking in the vicinity of the Northland and the Karori tunnels. The new bylaw doesn't actually establish any of the areas, just sets up the regulatory structure.

Separately, in April 2021, the Council agreed to revoke a 2005 parking guideline that allows some discretion on footpath parking that occurs outside of the central area and suburban centres. The Council wants feedback on how they should control and manage this problem, where it occurs. There is a whole FAQ about this matter on the WCC webpage (see link in the email below), and if you are interested, encourage you to read it and make a submission.

Also relevant to Northland's narrow streets are potential new rules to control large vehicles like motorhomes left on the street, derelict vehicles left on the street, use of parked trailers for advertising, positioning of rubbish skips on streets, etc.

If you are interested in providing feedback on this, I have attached a copy of the bylaw proposal, and a submission document, to this email. You don't have to submit on every single amendment that is proposed, only the ones which interest you

The closing date for submissions is **11 June**. CVRA will make a submission, so you can also email us with your thoughts, by the middle of next week.
